Grant of Performance Rights

The Company has today granted a total of 1,214,027 Performance Rights to eligible executives and employees pursuant to their employment agreements and direction of the Board.

The majority of the Performance Rights totalling 814,027, may vest on 30 June 2020 or 31 December 2020 on the satisfaction of certain performance conditions, based on the Company's relative and absolute total shareholder return performance and percentile ranking relative to comparator companies and overall business plan performance. The remaining 400,000 Performance Rights granted to employees may vest on 30 June 2017 or 30 June 2018 subject to certain retention and performance vesting conditions.

These Performance Rights have been issued pursuant to a new Performance Rights Plan (PRP) adopted by the Company. The new PRP was amended and updated to better reflect contemporary trends in corporate governance practice (particularly concerning extending vesting dates and more rigour as to vesting threshold criteria) and to allow for the participation of Non-Executive Directors (subject to shareholder approval). The amended PRP is being presented to Shareholders for approval at the 2017 Annual General Meeting.
