

GRANT OF PERFORMANCE RIGHTS

The Company has today granted a total of 4,782,162 Performance Rights to management personnel pursuant to annual invitations made in accordance with the terms of their employment contracts and the Company's Performance Rights Plan. These performance rights may vest on 30 June 2022 or 31 December 2022 on the satisfaction of certain performance conditions, based on the Company's relative and absolute total shareholder return performance and percentile ranking relative to comparator companies and overall business plan performance.

The Company has also granted a total of 536,678 Performance Rights to non-executive directors pursuant to fee sacrifice invitations made in accordance with the Company's Performance Rights Plan. These Performance Rights may vest on 30 June 2020 on the satisfaction of certain vesting criteria.
